A. Parent Ed

7. New Business:

A. Dillon Dear Match Penalty

- Bill heard nothing for 1.5 weeks and he typically hears back very quickly. He contacted Central Section and was told that no paperwork had been submitted, it may have been sent to the wrong section
- Bill heard via email that this Tuesday (12/06/16), will be 17 days, so Dillon can practice on that day
- The ref was suspended for mishandling the paperwork. Bill enquired when the suspension began so that we can monitor the ref

B. Senior Day

- Bill contacted Tina Guley and she agreed to organize Senior Day for the League
- Will be held the weekend of January 14, 2017. Next year we may be able to run four games on Sunday so all Senior Days will be on the same day
- Tina will contact Reps with the information needed from the players
- Tina needs all bios by January 3 in order to process the printing. She asks that Reps submit all seniors from their team at the same time

C. By-Law Change for Charges

- The by-laws state that once the cost/team is determined, the team is responsible for that amount
- This needs to be updated
- 1. By-Law payment change for players with season ending injuries
 - \$150- start of team's practice up to the team's first payment date set by the league treasurer (around November 15th)
 - \$300- after the team's first payment up to the team's second payment date set by the league treasurer (around December 15th)
 - \$500- after team's second payment up to the team's third and final payment date set by the league treasurer (around January 15th)
 - Full payment due after the final team payment (around January 15th)
- Bill added "from date of contact with the league president", notification from the doctor to the Board
- What if the injury ends up not being season ending, there needs to be a clause for reinstatement
 - o "if the player requests reinstatement, the player will pay the full cost for the season", as long as a roster spot exist for the returning player
- 2. By-Lay payment change for players guitting prior to the season beginning
 - Any players that quit prior to the first game of the BCHSHA season shall be charged \$20/team's scheduled practice session, with the team reimbursing the League the practice cost.
 - Once the BCHSHA season begins, a cost/player will be adjusted for ALL players based on the number of players in the League at that point in time.
 - If a player quits after the start of the BCHSHA season, the team will be responsible for incurring the player's cost for the entire season
- Bill added "from date of contact with the league president"

D/E.Board Coverage/ Reps Info

- Board coverage is for emergencies, not for babysitting fans, etc. Reps are the first line of contact with spectators since they will likely know the Reps.
- Board is second, SUNY Broome staff is third, Sheriff is fourth. The Reps stepping in makes it easier for everyone involved
- Reps that are giving free entry to grandparents for their home games need to make certain that the grandparents know that it is for their home games only
- · Social media
 - We have a couple of anonymous Twitter accounts out there; for example BHS has an account and no one knows who's running it. There is stuff on it that blatantly violates USA Hockey regulations; no cameras in locker rooms- pictures taken in the team locker room
 - Coaches need to remind players that there are to be NO pictures in the locker room. Even if it's anonymous, anyone that posts on these accounts can be disciplined
